Action Taken Report 2014-2015

Based on the curriculum evaluation by teachers the following actions were taken. More than 75 % of the teachers are under the opinion that the syllabus is suitable to the course and around 75% of the teachers agree with the opinion that the syllabus is need based. It is recommended to the board of studies members to make the necessary changes in the syllabi. Majority of teachers are agreeing that the syllabi are well defined and clear to teachers and students, and the course content is followed by corresponding reference material. 25 % of the teachers have the opinion that sufficient number of prescribed books are not available in the library. The council head decided to generate enough fund for purchasing more books to the library. Each department has a department library in addition to the central library. Majority have the opinion that the books listed as reference materials are relevant updated and appropriate. Around 90 % of the teachers are strongly agreed that the test and examinations are conducted well in time. Faculties have less freedom to propose, modify or suggest new topics in the syllabus. But they can in co-operate their suggestions to the board of studies members during the syllabus revision time. The university is giving provision to the faculties to attend refresher courses, orientation programmes and they can join in faculty improvement programmes. As per the university regulations every teacher has to attend certain number of refresher and orientation programmes.
