Action Taken Report

Curriculum Evaluation by Teachers 2016-2017

Based on the curriculum evaluation by teachers the following actions were taken. More than 80 % of the teachers are under the opinion that the syllabus is suitable to the course. Only 60% of the teachers agree with the opinion that the syllabus is need based. It is recommended to the board of studies members to make the necessary changes in the syllabi. 95% of teachers are agreeing that the syllabi are well defined and clear to teachers and students, and the course content is followed by corresponding reference material. Less than 15% of the teachers have the opinion that sufficient number of prescribed books are available in the library. The council had decided to generate enough funds for purchasing more books to the library. Each department has a department library in addition to the central library. Majority have the opinion that the books listed as reference materials are relevant updated and appropriate. 70% of the teachers are strongly agreed that the test and examinations are conducted well in time. Majority of the faculties from science stream, could not able to cover the syllabi properly in time since the number of working days for one semester is less. It is recommended to the board of studies to modify the syllabus according to the present scenario. Faculties have no freedom to propose, modify or suggest new topics in the syllabus. But they can in co-operate their suggestions to the board of studies members during the syllabus revision time. The university is giving provision to

the faculties to attend refresher courses, orientation programme and they can join in faculty improvement programmes. As per the university regulations every teacher has to attend certain number of refresher and orientation programmes.
