ACTION TAKEN REPORT2013-2014

Based on the curriculum evaluation by teachers the following actions were taken. More than 80 % of the teachers are under the opinion that the syllabus is suitable to the course. Only 50 % of the teachers agree with the opinion that the syllabus is need based. It is recommended to the board of studies members to make the necessary changes in the syllabi. 90 % of teachers are agreeing that the syllabi are well defined and clear to teachers and students, and the course content is followed by corresponding reference material. Less than 20% of the teachers have the opinion that sufficient number of prescribed books are not available in the library. The council head decided to generate enough fund for purchasing more books to the library. It is decided to set up department library for each department in addition to the central library. Majority have the opinion that the books listed as reference materials are relevant updated and appropriate. All most all the teachers have the opinion that thecourse/syllabushasgoodbalancebetweentheoryandapplication. Majority of the teachers have the opinion that course/syllabushasmadeinterestedinthesubjectarea. More than 90% of the teachers are agreeing that the books prescribed/listed as reference materials are relevant, updated and appropriate. The faculties have less freedom to propose, modify, suggest and incorporate new topics in the syllabus. Majority of the faculties from science stream, could not able to cover the syllabi properly in time since the number of working days for one semester is less. It is recommended to the board of studies to modify the syllabus according to the present scenario. Faculties have no freedom to propose, modify or suggest new topics in the syllabus.

But they can in cooperate their suggestions to the board of studies members during the syllabus revision time. The university is giving provision to the faculties to attend refresher courses, orientation programmes and they can join in faculty improvement programmes. As per the university regulations every teacher has to attend certain number of refresher and orientation programmes.
