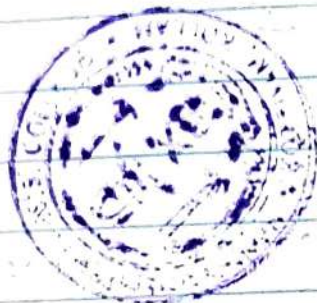

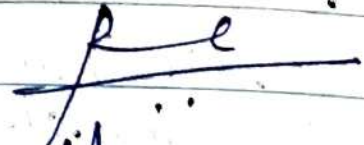

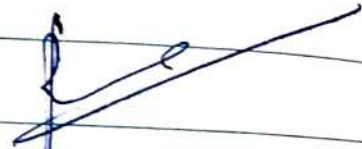
The meeting discussed the following points
