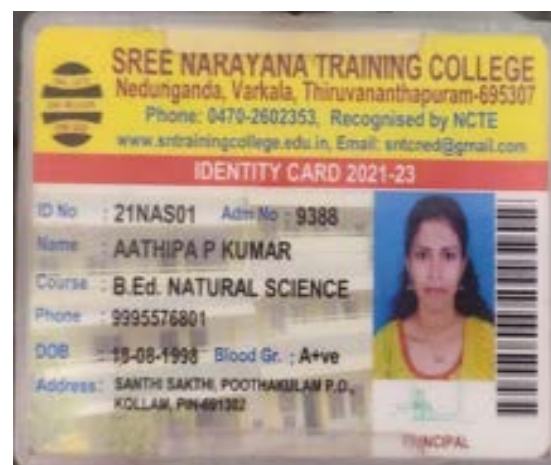

In order to do this we need to record something at each of the submission points. Our records system automatically calculates an overall grade, that we are unable to prevent, which is why the outcome may be showing as a fail grade, or, a lower grade than you might expect. Once you have submitted the work and it has been marked, the grade should then be updated. You will be able to see that you still have another opportunity to submit your work where you can see an * against the G grade.
